#### **"Developing Emergency Operations** Plans K-12 Training"

This session will take a look at these events along with our psychological response and provide options for a physical response to an active shooter and crisis situation.

Misbehavior is punished leaving the student to feel disconnected from school and at times also feeling like a victim. The goals of Restorative Practices apply not only to those involved in or affected by misbehavior, but to the larger educational community as well.
