# **Facilitating Formal Conferencing**

A 2-day training for making preparations and running formal conferences.

Conferencing is the most formal of the Restorative Practices on the continuum, and is an in-depth and time intensive practice. Formal Conferencing is a procedure that creates a structured meeting between the person who caused harm, the person who has been harmed and both parties' family and friends, in which they deal with the consequences of the offense and decide how best to repair the harm.



This session follows the IIRP framework

# It is strongly recommended that participants attend Restorative Practices for Educators and used these skills before attending this training.


# TRAINING: A PROFESSIONAL LEARNING EXPERIENCE WITHIN A RESTORATIVE COMMUNITY

### During 2-day training, you will engage in experiential learning in the following areas:

- Build relationships with a community of adult learners to improve your professional practice.
- Identify the purpose of Formal Conferences.
- Explore the difference between problem solving circles and Formal Conferences, as a part of the RP Continuum.
- Engage in 5 role plays of different school-based scenarios to gain proficiency in facilitating a Formal Conference.
- Reflect on the needs of all participants in the conference process.
- Identify how Formal Conferences can be used in your setting as a way of addressing and responding to harm.
- Reflect on equitable practices in relation to building a restorative school culture.

# A IMPLEMENTATION COACHING AND CONTINUED LEARNING AFTER TRAINING - RECOMMENDED


