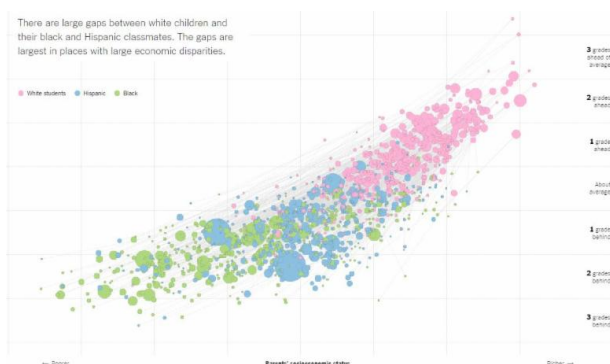

FDA Finalizes Its Authority on All Tobacco Products

Earlier this month the FDA announced their final rule on tobacco products, a rule that also includes e-cigarettes and premium hand-rolled cigars. The new rule requires the FDA to approve all tobacco products (including e-cigarettes) not currently regulated that went on the market after February 2007. Components and parts of the newly deemed tobacco products, but not their related accessories, are included in the scope of this final rule. The rule also includes the following:



- Covered tobacco products cannot be sold to persons under the age of 18 (both in person and online)
- Photo ID is required for all tobacco sales
- Covered tobacco products cannot be sold in vending machines (unless in an adult-only facility)
- Free samples are not allowed

Product manufacturers have two years to comply with the law. [Read more](#)
