
#### **WISH Center Needs Assessment 2016 Results**

#### **Methodology and Demographics**

Professional development needs for school health and safety were assessed using an online survey conducted from February 15, 2016 to March 15, 2016. The survey link was emailed out by the WISH Center director in a newsletter as well as by the DPI and Regional Coordinators to local school district email lists. We received 521 responses from educators throughout Wisconsin. Similar assessments were conducted in 2012, 2013, 2014, and 2015.


# What level do you most often serve: (Select all that apply)

**Top 10 Needs Overall** 





Overall top needs changed slightly from the previous years. Helping Students with Mental Health Issues, Internet Safety, and Emerging Drug Trends remained the top needs. Mindfulness Practices for Students & Staff moved from #7 in 2015 to #2 in 2016. Trauma Sensitive Schools also moved into the top 10 needs nudging School SBIRT to #11 for the statewide results. The top 10 remains relatively stable when you look at the results by CESA Region.





## **Training Logistics & Technical Assistance**



Most participants report they want to access training at their local CESA (86%) during the school year (92%). Each year, more people (32% in 2012 to 40% in 2016) report that they would attend training using online learning tools such as Moodle, Zoom, or other distance learning platforms.



When asked what technical assistance they need, 175 participants reported needed help with Youth Risk Behavior Survey analysis, reporting, or application of information, 72 reported needing coaching for implementation and evaluation after training, and 63 reported they would be interested in a site visit-school safety walk through and review of their crisis and safety plan.
