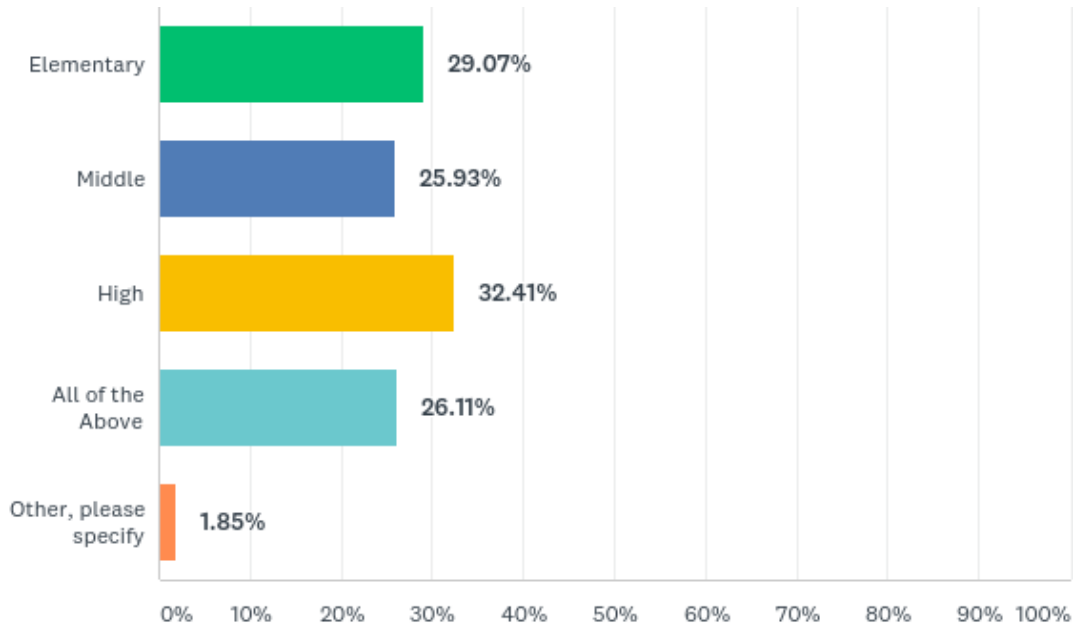


WISH Center Needs Assessment 2018 Results

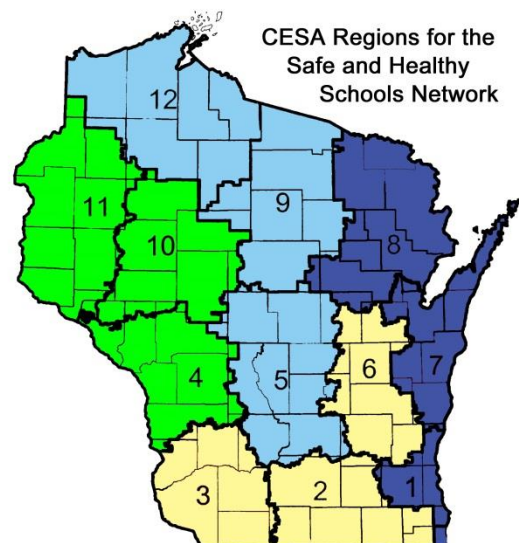
Methodology and Demographics

Professional development needs for school health and safety were assessed using an online survey conducted from March 1-30, 2018. The survey link was emailed out by the WISH Center director in a newsletter as well as by the DPI and Regional Coordinators to local school district email lists. We received 540 responses from educators throughout Wisconsin. Similar assessments were conducted in 2012-2017.

Overall top needs changed slightly from the previous years. Helping Students with Mental Health Issues was identified as the top need. This was the second year we asked about SEL and it moved from the top need in 2017 to third. Emerging Drug Trends, Mindfulness Practices for Students & Staff, Cyberbullying, Trauma Sensitive Schools, Relational Bullying, and How to Assist Students with AODA Issues remained in the top needs identified. Mental Health Screening Tools and PREPaRE 2 moved up slightly from 2017. The top 10 remains relatively stable when you look at the results by CESA Region.

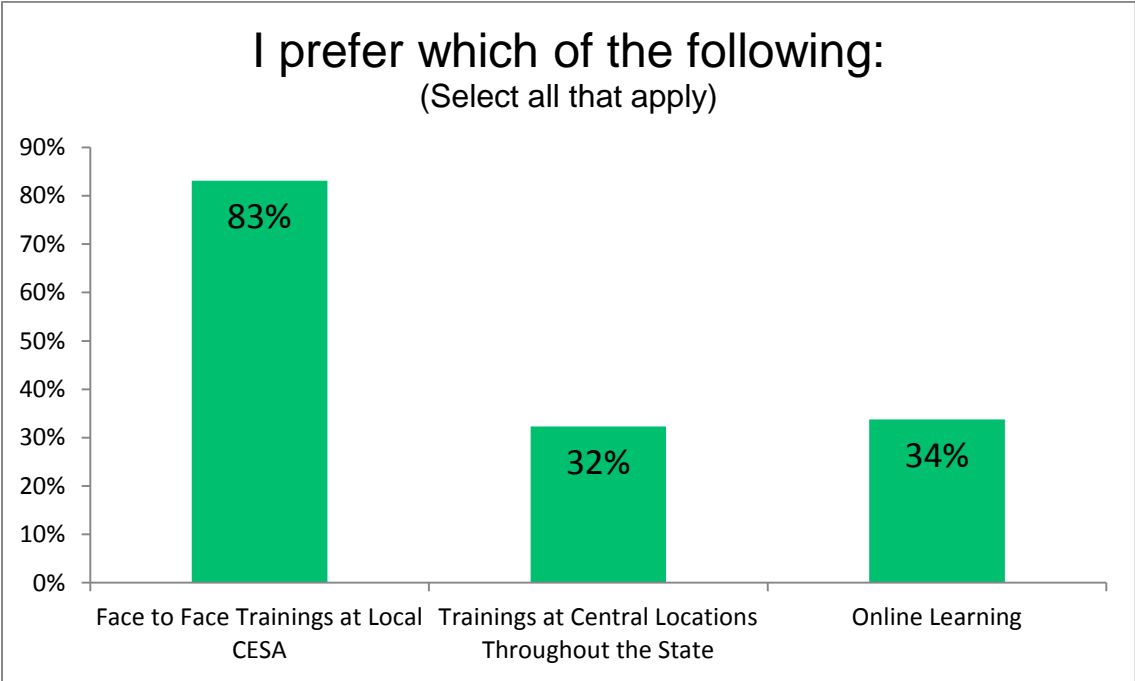

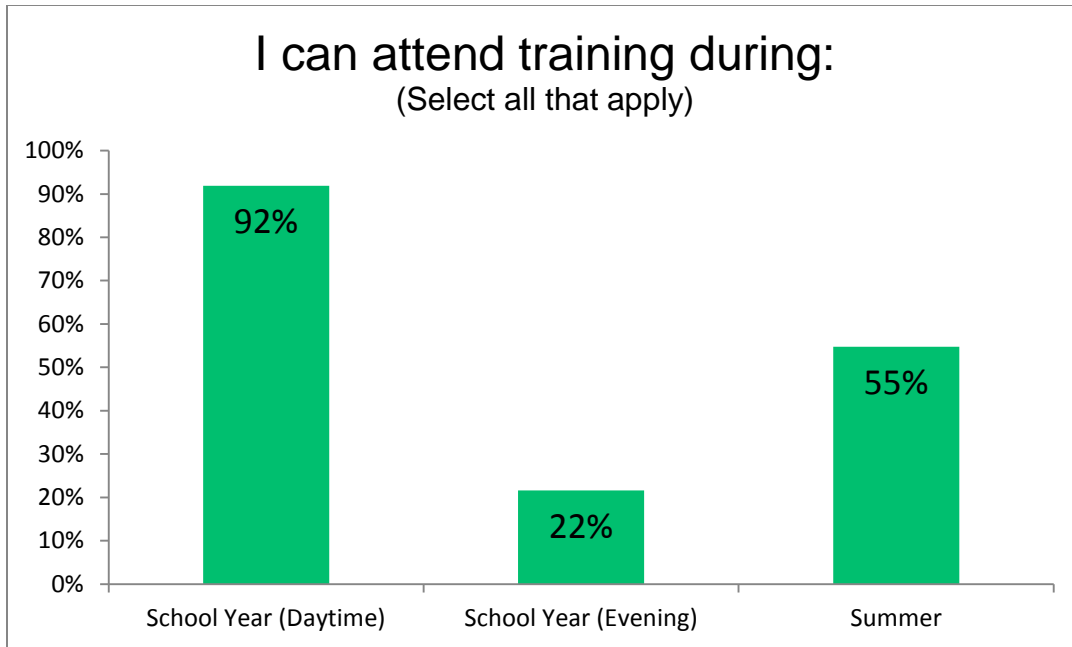

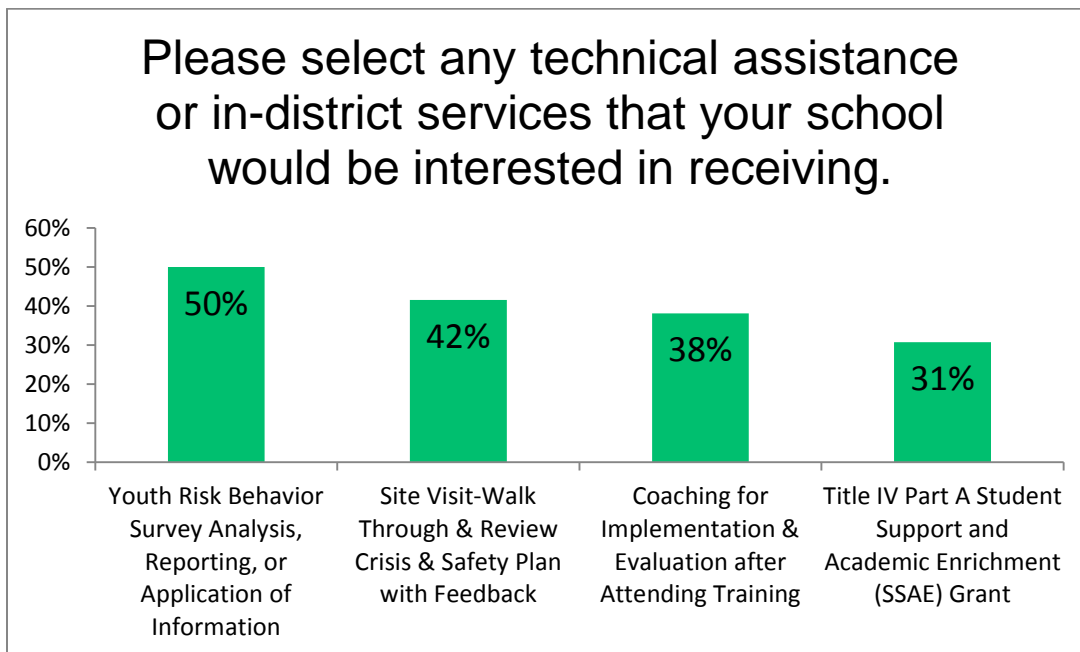
Training Logistics & Technical Assistance



Most participants report they want to access training at their local CESA (83%) during the school year (92%). The number of people reporting they would attend online training decreased from 40% in 2017 to 32% in 2018.

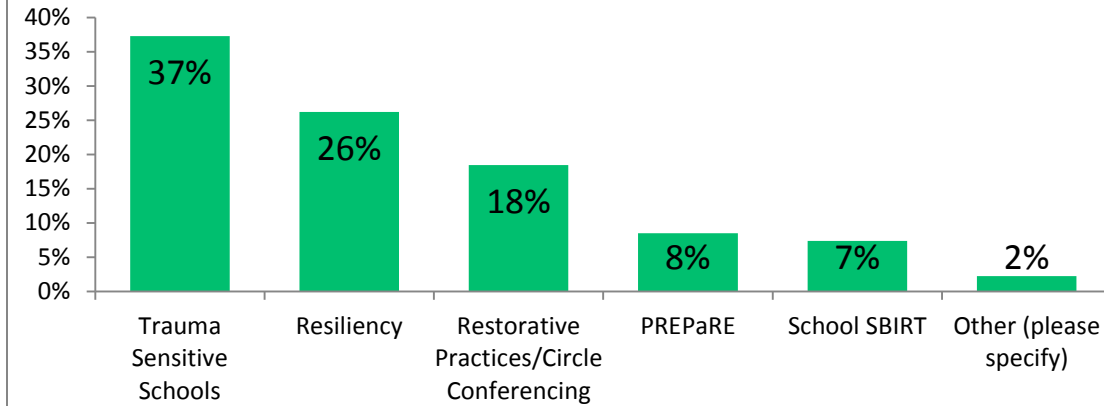


Most people reported they can attend training during the school year in the day time. The number of people reporting they can attend summer training remains the same as 2017 at 55%.



When asked what technical assistance they need, 50% (130 participants) reported needed help with Youth Risk Behavior Survey analysis, reporting, or application of information, 42% (108) reported they would be interested in a site visit-school safety walk through and review of their crisis and safety plan, 38% (99) reported needing coaching for implementation and evaluation after training, and 31% (80) requested assistance with Title IV Part A Student Support and Academic Enrichment (SSAE) Grant.

As the WISH Center grows its capacity, we are investigating how to support schools in implementation after training. 271 people responded they were interested in technical assistance/coaching for implementation on a variety of topics displayed in the above chart.
